COVID-19 School Notification - Positive COVID-19 Cases in School

March 10, 2021

Dear Parents/Guardians:

This letter is to inform you that we have multiple NEW cases within the district:


1. Since the last notification, we have an **additional 5 individuals** who tested positive for COVID-19 at the **Middle/High School**. Since the school is currently on remote status, these individuals were not in the building. As part of our protocol, the Bergen County Health Department was contacted. **All in-person middle and high school co-curricular and extra curricular events, and high school athletics are prohibited during this time. The Middle and High school will return to in person instruction on Thursday, March 18, 2021.**
2. One individual at **Smith School** tested positive for **Coronavirus Disease 2019 (COVID-19)**. This individual was not in the school building during a contagious period. As part of our protocol, the Bergen County Health Department was contacted.
3. Two individuals at **Long School** tested positive for **Coronavirus Disease 2019 (COVID-19)**. These individuals were not in the school building during a contagious period. As part of our protocol, the Bergen County Health Department was contacted.

The District is coordinating closely with public health officials and following CDC, state, county and local health department guidance in order to assure the health and safety of our community. **If any further developments occur, you will be notified in a timely manner. Close contact is defined by the [NJDOH](#).**

After weeks of decline, the state is seeing increases in cases. You can view the [Coronavirus Tracker here](#). The Saddle Brook School District has seen its total active cases (measured by the total within a two weeks window) hit an all time high and is continuing to climb with 8 more cases this week. Meanwhile, there is mounting pressure to open schools. The region and district is still in the **ORANGE zone, our rate of positive cases in Bergen County is 25 per 1000, and our district has realized the impact of this. See [NJ.COM article here](#). The district will continue to analyze the state and regional data, and the local positive COVID case numbers to protect the health and safety of the students and staff before we make any additional changes to our schedule. The decisions we make **MUST** be data driven.**

Please do not allow sunshine and warmer days to distract us from our need to regularly socially distance, wear masks and disinfect our hands. Please do not send sick children to school. As always, we appreciate our community's support and cooperation. You can assist us by remaining vigilant but sensible in your approach to dealing with this health concern.
