COVID-19 School Notification - Positive COVID-19 Cases in School

March 14, 2021

Dear Parents/Guardians:

This letter is to inform you that we have multiple new cases within the district:

1. One **new individual** at the **Middle/High School** has **tested positive for Coronavirus Disease 2019 (COVID-19)**. This individual was NOT in the school during the contagious period. This is not a contracting notification.

Reminder: All in-person middle and high school co-curricular and extra curricular events, and high school athletics are prohibited during this time. The Middle and High school will return to in person instruction on Thursday, March 18, 2021.

2. One new individual at **Long Memorial School** tested positive for **Coronavirus Disease 2019 (COVID-19)**. This individual was last in the building on March 11 and was presumed contagious at that time.

IMPORTANT: Due to the nature of this individual's role in the building, and the role of the key faculty and staff impacted by the close contact, Long School must shift to remote learning through March 24th. In-person instruction will begin again for the Blue cohort on March 25, and the Gold cohort on March 26. Close contact is defined by the [NJDOH](#). Long Memorial School staff has contacted ALL those who are required to quarantine. Please check your phone messages and emails.

As part of our protocol, the Bergen County Health Department was contacted. The District is coordinating closely with public health officials and following CDC, state, county and local health department guidance in order to assure the health and safety of our community. **If any further developments occur, you will be notified in a timely manner.**

Cleaning and disinfecting of all exposed areas is being completed. The school is also taking precautions to prevent the introduction and spread of viruses and other germs, cleaning frequently touched surfaces daily, multiple times daily, and sometimes by the hour. We utilize numerous approved disinfecting and cleaning products that destroy COVID-19 as well as other viruses and bacteria. We are monitoring the status of this situation very closely.

We understand the level of concern regarding COVID-19. We encourage parents and students to continue following the [Centers for Disease Control & Prevention](#) promoted safeguards, such as:

- Avoiding social gatherings;
- Staying home when you are sick;
- Washing hands often with soap often and for at least 20 seconds;
- Covering coughs and sneezes and properly disposing of tissues;
- Limiting close contact with people who are sick and not sharing food, drinks and utensils;
- Practicing social distancing (staying at least 6 feet apart);
- Wearing a face covering;

- Getting a flu shot to prevent taxing the medical systems with flu outbreak; and
- Continuing to monitor your health for COVID related symptoms.

After weeks of decline, the state is seeing increases in cases. You can view the [Coronavirus Tracker here](#). The region and district is still in the **ORANGE zone**, our rate of positive cases in Bergen County is 25 per 1000, and our district has realized the impact of this. See [NJ.COM article here](#). The district will continue to analyze the state and regional data, and the local positive COVID case numbers to protect the health and safety of the students and staff before we make any additional changes to our schedule. The decisions we make **MUST** be data driven.

Please do not allow sunshine and warmer days to distract us from our need to regularly socially distance, wear masks and disinfect our hands. Please do not send sick children to school. As always, we appreciate our community's support and cooperation. You can assist us by remaining vigilant but sensible in your approach to dealing with this health concern.
